- First months after marriage
- Where did you live after marriage
- Ability of you and your spouse to communicate with one another
- When did problems first arise in the marriage
- What was the nature of these problems (give details)
- Were there children born of this marriage
- Any temporary separations before the final breakup

4. Final Separation

- Details regarding reasons and incidents that led to the final separation
- Date of final separation
- Have both parties assumed financial responsibility for any children born of this marriage

5. After The Breakup of The Marriage

- Since the breakup of the marriage, what is the relationship between you and your spouse?
